Professional Development Seminar

Chemistry and Criminalistics Victor C. Reeve Laboratory Director (seminar outline)

The participants in this year's seminar will be guided by Laboratory Director Victor Reeve, a forensic scientist with thirty five years experience in the Crime Laboratory business. Utilizing John Houde's excellent text as pre-reading, each student will enter the

Crime Laboratory and will focus on the applications of Chemistry to Physical Evidence. Initially, we will study examples drawn from the text "Crime Lab: A Guide For The Non-Scientist"; then our journey will take us to famous cases such as O.J.Simpson matter. Finally, their guide will share his experiences drawn from cases worked while in the employ of the Royal Canadian Mounted Police and from the California State Department of Justice's Sacramento Crime Laboratory.

.(The study material will be supplied to pre-registrants).

In addition to Mr. Reeve's seminar, the Canadian Security and Intelligence Service will talk about industrial espionage. We also hope to have a member of the Royal Canadian Mounted Police Forensic Laboratory give talk on how the RCMP lab operates. (This speaker has not been confirmed at this time)

Because of the added cost of bringing the speaker to Canada we will require a commitment from each of you who wish to attend and prepayment by Jan 15. Please e-mail Bob Swingle bswingle@cal.maxxam.ca with your intentions and numbers from your office who might

From the President

It's September again and life for most of us is getting back into high gear (if it ever got out of high gear over the summer). It is my pleasure to serve as President of the ACPA for the next year. The Board has several things on the agenda to be accomplished in the next 10 months

First and most important is the finalization of the Association's Professional Status. I know you have heard this before but we believe that we are very close to achieving our goal. One of the problems we have had over the years is re-organization within government departments and the lack of continuity within the departments and governmental committees. Kevin Dunn, in his Report from the Past President, outlines the current situation.

Briefly, the Professional and Occupational Association Registration Act (POARA) requires that the **APCA** membership ratify the Professional Chemists Regulation. A majority vote in support of the Regulation will enable us to get the document to a second review by the Standing Policy Committee and onto the

order paper in the Legislature. Premier Klein may put a wrench into these plans if he calls an election in the early Spring which will probably cause a delay in getting on the order paper. Your prompt return of the ballot on the Regulation will help us keep the process Remember moving. ratification ballot will be sent only to paid up members for 2000. There is still time for you to get your membership dues paid and be included in the voting process.

Secondly, we are undertaking to set up an ACPA website this This will give the vear. Association a location that we can manage ourselves. One of the comments at the AGM this year was that our site on the ACPO website was a couple of years out of date. Having our own site will enable us to keep it current. It will give the membership easy access to the Board, access to AGM minutes, links to other chemistry related sites and a way for the Board to give easy access to documents like the Professional Chemists Regulation without relying on "snail mail."

One of my objectives this year is to raise awareness of the Association in the Province of Alberta. The Board is working on couple of initiatives to this end.

Some of you may be aware that Alberta Environment (AB ENV) is undertaking a review of the Alberta User Guide for Waste Managers. The Board has made representation to the consultant (Stantec) undertaking this work for Alberta Environment to be included as a stakeholder in this review. It is our belief that chemists can offer valuable input to the review since a significant portion of the User Guide relates to analytical

methodology other and principles we work with on a day to day basis. Alberta Environment to our knowledge one chemist in the department and a myriad of engineers, hydrogeologists, etc. By getting involved in this process as an Association, we may be able to get more consideration for the practice of chemistry by AB ENV. Erv Callin has volunteered to be the ACPA contact and coordinator for the Association's input to the process. This year we are going have a tabletop display at two technical/technology tvpe meetings in Edmonton besides our normal presence during National Chemistry Week in Calgary and Edmonton. first meeting is the Edmonton Association of Technical Societies meeting Thursday. November 9. This is an annual gathering of most of the technical societies in the Edmonton area and will enable us to get our message out to other technical professionals. second meeting The Technology for Success 2000 on Tuesday, November 14. (More information about this can be obtained on the web at www.technologyforsucce ss.com). This symposium and trade fair is designed to provide information about emerging technologies and network with people in the high-tech business community. The more people in technology businesses that are that there organization that represents the chemical profession, the more

impact we can have and the more benefit the ACPA can be to its members. Ken Schmidt and Stan Backs are taking the lead in the Promotions and Special Events areas

In early February, we will be holding our second 1 day Professional Development Workshop on consecutive days in Calgary and Edmonton. The topics are "Forensic Chemistry" "Industrial Espionage". The session on "Forensic Chemistry" will be lead by Victor Reeve from California Department of Justice. Victor worked in the RCMP's crime labs before going the United States. The other speakers being are finalized. We are looking forward to an another interesting seminar.

Report from the Past President

We are optimistic these days. We believe that this last Annual General Meeting (AGM) was our last under the Societies Act. We foresee that next year's AGM will be our first under the Professional and Occupational Associations Registration Act (POARA).

Our application has gone through all the required steps. This has included a second stakeholders review of the draft regulation conducted late in 1999 and a recent review by

Legislative Counsel. We have a few details to tidy up, and then, following a second review by the Standing Policy Committee, the Professional Chemists Regulation will be ready to hit the order paper in the legislature.

Your involvement as an ACPA member is essential to make this happen. The revised final edition of the regulation will be mailed separately to members who have paid by October 31. We need you to review the regulation and indicate on the enclosed ballot whether you support this regulation in its present form. A majority of members must demonstrate their support for the regulation for it to continue through POARA's process. Of course, if you find it deficient, we want to hear about it. Please give us any feedback you feel is appropriate. Note that some requirements, such as the expiry date, are a POARA requirement, about which we can do very little.

If you did not get a copy of the regulation for review, it is because you have not paid your dues, and are not entitled to vote. Additional ramifications of not paying your dues include having to re-apply registration as a Professional Chemist, and pay the application fee, again. All members in good standing will automatically have their status transferred over to the registry under the regulation when it is passed.

In preparation for the ACPA's registration, we have been busy developing the processes required to make a professional organization function. One of these is the system of Professional Development Credits. We published the first draft of the system in the second-last newsletter. Thanks to the feedback provided by

many of you, we were able to refine and improve the system. The improved version was published in the last newsletter and was subject of lively discussion at the AGM. We plan to test the system later this year. We will be asking many of you to participate in this "betatest" to see how it works with real working chemists.

In other news, we are well underway organizing professional development workshop for next year. We have topics and speakers that we are sure vou will fascinating. The topics include forensic chemistry and industrial espionage. This workshop is part of a continuing series of workshops that will help you Professional obtain Development Credits and further upgrade your own skills and knowledge. Suggestions for future workshops are always welcome, as are volunteers to help with the organization of these events.

Over the past year, we have participated in judging local science fairs, provided speakers to chemistry careers nights at the University of Calgary and University of Alberta and contributed to activities in conjunction with the local Chemical Institute of Canada sections. We are also working with the Canadian Society for Chemistry, the Association of the Chemical Profession of Ontario and the Ordre du Chemistes du Ouebec to establish the "P.Chem." title across the country.

Finally, you may have noticed a new look for the newsletter banner. Yes, we have a new logo. We thought it was time that we projected a more professional image, beginning with the new logo. We hope you like it.

It has been my great pleasure and a great privilege to serve as your President the past couple of years. I will be continuing my involvement with the ACPA Board of Directors, and I look forward to the leadership of Don White, your new President.
