# **Treasurers Report**

As of February 28 the ACPA had an unaudited balance is \$15,746,38.

The current operating costs of the association are very modest, with much of the work accomplished through volunteer efforts. Nonetheless, expenses are incurred. In 1998, the association income of \$3675.00 exceeded the expenditures of \$2897.53 in by \$777.47. While this is sufficient to meet the current obligations, it does not provide much cushion for unexpected expenses or for setup costs after registration under POARA (Professions and Associations Occupational Registration Act).

In planning for the future, the Board has taken two steps. One has been to raise the annual membership fees from \$25.00 to \$50.00. The other has been to organize professional seminars such as the one held in Calgary on February 4<sup>th</sup> of this year. This seminar was very successful both in terms of professional education and as a source of income. This event raised nearly \$5000.00 for the ACPA. Seminar expenses were covered by several generous sponsors Laboratories, (EnviroTest Matrix Solutions, Hewlett-Packard, Maxxam Analytics, Jacques Whitford

Environmental and NorWest Labs).
